Board of Directors Policy Regarding Endorsements and/or Partnerships

Programs/projects that complement the mission and purpose of student council may be considered by the Board for an endorsement/partnership. Programs or projects interested in forming a partnership with TASC must demonstrate in writing the ways in which the program enhances the work of or provides a resource to student councils. Programs/projects sponsored by member schools are preferred. The Board will approve this type of relationship at the summer board meeting. The board may determine to limit the number of endorsed programs. These relationships benefit TASC member schools directly, either by providing a resource to the council or to individual students. Endorsed programs often exhibit at TASC events and present at TASC events. Benefits to an endorsed program/partner may include access to member schools data for marketing, inclusion in conferences through presentations and reduced exhibit rates, a link on the TASC website, and inclusion in the TASC Resource Guide. Relationships are established by a board vote and are renewed annually. Existing programs must demonstrate participation by and benefit to schools and justify the continuation of the relationship in writing.

We continue to be a resource for schools and student councils across the state so that faculty, staff, & students can understand and access legal solutions to dating violence & sexual assault. Texas Advocacy Project also offers volunteer opportunities year-round, and teen-focused initiatives such as our Teen Ambassadors of Hope campaign.
What is the benefit of this partnership to the TASC organization as a whole, its member schools or individual advisors/students?	Dating violence and sexual assault education is crucial for schools and student councils so that they can respond appropriately to incidents, and more importantly, prevent occurrences of intimate partner violence on campuses.
What is the benefit of this partnership to your organization?	This partnership allows us to spread awareness and information to a high-risk age group for intimate partner violence, helping to fulfill the primary goal of our organization.
Is there a fee for TASC schools to attain resources or participate in the program	No. All of our legal resources and trainings are completely free of charge.
Does participation in this program require student fundraising of any type?	No. Students are able to receive trainings, legal resources, or volunteer without any funds or fundraising necessary. One of our teen programs, Teen Ambassadors of Hope, does have a fundraising component, however, our primary goal of being a TASC partner is to provide free training and legal resources to student leaders
Is this program available to student councils statewide?	Yes.
Describe in detail the resources available to TASC schools through this partnership.	Student, faculty, and staff can request trainings from Texas Advocacy Project at any point in the year at no cost. We offer a wide-range of teen outreach trainings, and can also consult with student councils and staff about legal responses to intimate partner violence, and prevention education.

Our goal for this upcoming year is to help lighten the load of the faculty at schools and provide free resources and training opportunities for teens. This past year has been stressful and we want to ensure that we can help each school.

We would love to continue presenting on similar topics, such as recognizing teen dating violence, legal rights of teen dating violence, sexting & cyberbullying, and more.
